

**COMMUNAUTÉ DE COMMUNES RAHIN ET CHÉRIMONT –  
FISHERY REGULATIONS  
- LES BALLASTIÈRES**

**ARTICLE 1**

The Communauté de Communes Rahin et Chérumont (CCRC) is the owner of the two bodies of water known as “Ballastières”, the management of the fishery is provided exclusively by the CCRC.

The CCRC disclaims all responsibility for:

non-compliance with this regulation,  
accident,  
theft,

of which could be victims fishermen or escorts on the site of Ballastières.

**ARTICLE 2**

The right to fish in water bodies can only take place if the fisherman has in his possession an annual, monthly, weekly or daily fishing card. Any fisherman in possession of a card is allowed to fish with 4 rods max. The interval between 2 rods cannot exceed 2,19 yd. Any fishing rod that is out of sight of its owner will be considered abandoned and will be seized by the guard or steward.

**ARTICLE 3**

The price of the membership card is reviewed annually.

Fishing is free for children under 14. Fishing allowed with only one rod included in those of its companion, no additional rod is accepted. Warning! Children under the age of 14 must be accompanied by an adult.

The cards will be issued at the point(s) of sale cited at the end of this regulation. Mandatory identification.

**ARTICLE 4**

The Ballastières are private water bodies, anyone wishing to fish must pay the fishing fee to the owner, the Community of Communes Rahin and Chérumont.

The purchase of the fishing card, concluded between the fisherman and the owner, compliance with this regulation. Failure to comply with this regulation by the fisherman will result in the final withdrawal of his fishing card, without refund. This withdrawal will be justified with a member of the CCRC in the presence of the fishing keeper and the fisherman concerned. Anyone who has been checked without a licence will be liable for the fishing fee for 24 hours. If they wish to stay fishing, they will have to pay the corresponding fishing fee.

**ARTICLE 5**

Fishermen must park in the car parks provided for this purpose.

**ARTICLE 6**

We make it clear to fishermen that any development of the edges of water bodies is prohibited.

The CCRC declines all responsibility in the event of an accident occurring on these facilities. Attention! In the event of non-compliance with Article 5, the offender will be permanently excluded.

**ARTICLE 7**

All fisheries on the water bodies of the Ballastières are in **NO KILL**. Reception mats, weighing, mandatory. Release mandatory. Fishing for life and death forbidden way, hard bait allowed. **ALL NIGHT FISHING IS FORBIDDEN**.

**ARTICLE 8**

PROHIBITIONS:

- entering the campsite (access is reserved only for campers);
- camping in the vicinity of water bodies outside the campsite (see Municipal Decree of 12 May 2005);
- to build any development;
- to delineate a square with twine or any other object;
- to leave on the places and approaches of the bodies of water any detritus; to make fire on the ground (portable barbecue permitted except prefectural provision in force);
- to put branches of trees or others in the water, in order to attract the predator;

- to fish in areas marked by signs.
- to sail by boat or inflatable boat (except events see calendars);
- mark any fish by mutilation or any other means;
- the use of echo sounders, deep sounders or radio-controlled primer boats, float-tubes or boilette guns during off-day events;
- priming in a disproportionate way, in particular with boilies and flour.
- use braided stockings and fish with more than one stocking per line.
- entering the water, abusively for throwing (MAXIMUM LENGTH OF CANE ALLOWED);
- to fish with a triple or double hook any species of white fish.

- braiding on a prohibited reel (line head authorised up to 5 metres).

- to fish from its vehicle, it must be parked on the car parks intended for this purpose.

- to park on emergency spaces reserved for fire-fighters' rescue boats. The areas concerned are the pier at the Chevanel pond and the access to the white barrier at the Breuil pond.

- park in front of the white barrier at the Pond du Breuil

**Attention any offences are liable to exclusion.**

**ARTICLE 9**

In order to preserve the biodiversity of the water bodies and to limit the presence of cyanobacteria, the priming is limited to 3.30 lbs/24h. Fishery guardians are authorized to control your seeding, including the use of properly cooked seeds.

**ARTICLE 10**

The checks carried out by the guard or guards can be carried out at the fishing place but also on the car parks around the cars.

**ARTICLE 11**

Animals must be kept on a leash. In the event of a major accident (bites, degradation of material, destruction of aquatic fauna, etc.) occurring on the banks of the Ballastières, the owner will be excluded from the site (after observation by members of the CCRC).

**Article 12**

On the first Sunday of each month, from 1 May to 31 November, Float tube fishing is allowed, in NO KILL.

**ARTICLE 13**

- SPECIFIC CLOSURE
- Pike and pike perch: closing from the last Sunday in January to the last Sunday in April.
- From 1 November, possibility of closure of fishing by display, for preservation of the nursery of autumn.
- Fishing is prohibited on the pond of Breuil in yellow zone from 1 July to 31 August inclusive.

**ZONE JAUNE**

Du 01 juillet 2025 au 31 août 2025 inclus  
La pêche est interdite.

Du 01 septembre 2025 au 30 juin 2026 inclus  
La pêche est autorisée avec 4 cannes  
perpendiculaires à la berge.

*From 01 July 2025 to 31 August 2025 inclusive fishing is prohibited. From 01 september 2025 to 30 june 2026 inclusive fishing is allowed with 4 rods perpendicular to the bank.*

**ZONE NOIRE**

La pêche est interdite toute l'année.  
*Fishing is forbidden all year .*

**ZONE VERTE**

La pêche est autorisée avec 4 cannes.  
*Fishing is allowed with 4 rods.*

**ZONE VIOLETTE**

La pêche est autorisée pour les résidents du camping détenteurs de la carte.  
*Fishing is authorized for campground residents holding a fishing permit.*
